RESOLUTION 2018-02 APPROVAL OF THE 2015-2040 METROPOLITAN TRANSPORTATION PLAN (MTP) REVISION #6

WHEREAS, pursuant to federal law, the Governor of the State of Texas designated the Harlingen-San Benito Metropolitan Planning Organization (HSBMPO) as the Metropolitan Planning Organization for the Harlingen Urbanized area; and

WHEREAS, the Harlingen-San Benito Metropolitan Planning Organization is the designated agency for transportation planning in the Harlingen-San Benito metropolitan area; and

WHEREAS, the Harlingen-San Benito Metropolitan Planning Organization Transportation Policy Board is currently the forum for cooperative decision-making regarding regional transportation issues; and

WHEREAS, the Harlingen-San Benito MPO staff has revised the 2015-2040 Metropolitan Transportation Plan (MTP) due to the following changes:

- The Harlingen – Loop 499 Sidewalks project was added to FY20;
- The Primera Stuart Place Road Sidewalks project was added to FY20;
- Added Business 77 project for illustrative purposes;
- Added Expressway 77/83 project for illustrative purposes;
- Added Harrison-Tyler project for illustrative purposes

WHEREAS, the Harlingen-San Benito MPO is required to provide all public and private interested parties with a reasonable opportunity to comment on the 2015-2040 Metropolitan Transportation Plan (MTP) revision # 6; and

WHEREAS, the required public comment period commenced on the 20th of November of 2017 and continued for a 30-day public comment period, which ended on the 19th of December of 2017;

NOW, THEREFORE, BE IT RESOLVED that the Harlingen-San Benito MPO Transportation Policy Committee, as the designated MPO for this area, agree by majority vote to adopt the 2015-2040 Metropolitan Transportation Plan (MTP) revision #6.

THEREFORE, BE IT FURTHER RESOLVED that the Transportation Policy Committee (TPC) delegates the signing of necessary documents to the TPC Chairperson.
